## Countries That *Normally* Exempt Ukrainian Citizens from Visitor Visa Requirements

Ukrainian citizens who are able to travel by air, perhaps once in a neighboring country, do not require an entry visa for tourism or business visits in over 65 countries.

Below is a simplified list of select destination jurisdictions into which Ukrainians require a visa and into which they do not.

- Please remember that in practice, entry requirements vary by jurisdiction and visa requirements for Ukrainians are subject to sudden change as the situation evolves.
- In most cases, visitors are not permitted to work. Also, visitors are typically required to show that they have return or onward travel plans, so Ukrainians may be subject to heightened scrutiny on this point when seeking to enter a country as a visitor.
