

COVID-19 Pandemic - Immigration Situation Overview

This is a summary of the confirmed immigration restrictions and/or concessions currently imposed by jurisdictions worldwide. Where applicable, it includes the following topics for each jurisdiction: (1) the operational status of government authorities; (2) travel restrictions; (3) travel and entry rules (including COVID-19 testing requirements and quarantine requirements); (4) other requirements; (5) digital health platforms and (6) any known concessions.

- Where a jurisdiction is not listed, Fragomen cannot reliably confirm it is currently imposing restrictions or concessions of this type.
- Not all jurisdictions contain a full list of sections; only applicable sections are listed. For example, a jurisdiction that does not have a digital health platform will not contain a Digital Health Platforms section.
- Benefits for vaccinated travelers are listed in the Travel and Entry Rules section, where such benefits
 exist. Vaccinated travelers should read this section and ALL other sections (including the 'Travel
 Restrictions', 'Quarantine Requirements,' and 'COVID-19 Testing' sections, if they are listed) to
 determine whether other requirements aside from the benefits listed, apply to them.
- While we list digital health platforms (for vaccinated and recovered travelers to display their COVID-19 immunization status) as mandated by country governments, airlines and other travel providers may use other available platforms. Be sure to check with your airline provider for more information.
- This summary is for reference only. It does not attempt to cover other developments that may be relevant to travelers, such as airline route cancellations, closures of consular posts, or national travel advisories. Individuals considering travel should consult their country's consular posts and seek case-specific advice from their travel and/or immigration providers. Employers whose staff have moved to remote work arrangements may need to complete additional labor law requirements, such as employment contract amendments.

Concessions

- Certain 'Short-term' stream Temporary Skill Shortage (TSS) and Subclass 457 visa holders who had applied for a Subclass 457 visa after April 18, 2017 that was subsequently granted can apply for a permanent Employer Nomination Scheme (subclass 186) visa under the 'Temporary Residence Transition' stream if they have been in Australia for at least 12 months between February 1, 2020 and December 14, 2021, and are employed by a person actively and lawfully operating a business in Australia. Standard employment, age and English requirements must continue to be met, although a new age exemption is also available to certain current or former Subclass 457 visa holders. It is expected this this will remain in place until July 1, 2024.
- Certain 'Short-term' stream TSS visa holders who are applying for a third TSS visa in the short-term stream can make a valid application without having to leave Australia. Specifically, this ability to apply for a third TSS visa applies to those who: were in Australia as the holder of a TSS visa in the Short-term stream for periods that total at least 12 months between February 1, 2020 and December 14, 2021; and make that further application before July 1, 2023, unless the Minister specifies a later date.
- As part of the wider reforms to the migration system and introduction of a possible pathway to employer sponsored permanent residency being made available to short-term stream TSS visa holders by the end of 2023, the Minister has announced that limits on the number of short-term stream TSS visa applications that can be made in Australia will be removed as an interim measure. This measure will be implemented once the relevant legislation has been updated.
- Certain Temporary Graduate (subclass 485) visa holders are eligible to apply for a new 'replacement stream' if they have been impacted by the Australian travel restrictions. This follows the automatic extension of certain Temporary Graduate (subclass 485) visa holders to September 30, 2022, to provide additional time for travel affected visa holders to apply for a replacement visa.
- Concessions to the occupation and skills assessment requirements also apply to Subclass 485 visa applications lodged under the Post-Study Work stream between July 1, 2022 and June 30, 2023. From July 1, 2023, the concessions will come to an end, with occupation and skills assessment requirements being reinstated.
- In addition, Temporary Graduate visa holders under the Post-Study Work stream who meet general eligibility criteria, have completed a qualification from the approved list and hold a valid Temporary Graduate visa on 1 July 2023 or apply for a Temporary Graduate visa before or after July 1, 2023 will have their visas automatically extended by 2 years.
- Individuals that hold a Temporary Graduate visa in the Post-Study Work stream that expire before July 1, 2023 and do not hold an eligible qualification may be eligible for a 2-year Temporary Activity Australian Government Endorsed Events (COVID-19 Pandemic) subclass 408 visa, subject to meeting all eligibility requirements.

- Certain current and former Skilled-Recognized Graduate (Subclass 476) visa holders who lost time in Australia due to COVID-19 related travel restrictions will have their visas automatically extended until April 2024. Eligible visa holders will be notified directly by the Department of Home Affairs of the extension of their visa and may arrive in Australia after this occurs. It will also apply to people whose visas have already expired, provided they were unable to use the full length of their original visa due to COVID-19 related travel restrictions.
- 'COVID-19 Pandemic event' stream applicants who have submitted their visas on or after February 21, 2022 are eligible to obtain a six-month Temporary Activity visa, regardless of the sector that they are or are proposing to work if they meet certain qualifications.
- TSS or Subclass 457 visa holders who have been subject to a 'Coronavirus reduced work period' or a 'Coronavirus unpaid leave period' during the specified COVID 'concession period' commencing February 1, 2020, may still be able to meet the qualifying 2 or 3 year employment required under the 'Temporary Residence Transition' stream of the permanent Employer Nomination Scheme (ENS) subclass 186 visa program if they meet certain criteria.
- Defined 'Coronavirus concession workers' will be able to meet the age exemption (which allows those 45 and over to apply for TSS or Subclass 457 visa holders where their annual earnings have been equal to or above a prescribed Fair Work High Income Threshold over a specified period) if their earnings have been affected by COVID resulting in a 'Coronavirus employment change' such that the TSS or Subclass 457 visa holder has worked at a reduced salary, worked reduced hours/part-time, been unable to work full-time, or been laid off.
- For this group, a pro-rata income threshold will apply to the period when their earnings were impacted by the pandemic if certain conditions are met. Working Holiday and Work and Holiday visa holders are eligible for a second or third visa when they have been performing "critical COVID-19" work, which is defined as medical treatment, nursing, contact tracing, testing and research; or support services such as cleaning of medical and health care facilities and equipment. The work can be performed at any location in Australia but must have been undertaken after January 31, 2020.
- Working Holiday Maker visa holders are eligible for a second visa if they have completed at least three months of specified work while holding their original Working Holiday Maker visa. A third Working Holiday Maker visa is available if the visa holder has completed at least six months of specified work while holding their second Working Holiday Maker visa.
- Fee waivers of the Visa Application Charge will be available for subsequent TSS visa applications for holders of subclass 457 visa or TSS visas and who were either unable to travel to Australia or had travelled and departed but were unable to return before their visa ceased due to the COVID 19 travel ban. This concession will apply to those who held a TSS or subclass 457 visa while travel restrictions were in place and require a new visa in order to re-enter Australia.
- The flexible work right arrangements for student visa holders and their dependents will expire June 30, 2023. The temporary arrangements allow certain student visa holders and their dependents to undertake full-time work in any sector even before the commencement of their course. After June 30, 2023, student visa holders and their dependents will only be able to undertake employment that is consistent with the regular conditions of their visa. However, from July 1, 2023, the work hours limitation will be increased from 40 hours to 48 hours which would mean that student visa holders will be permitted to work up to 48 hours per fortnight once their studies have commenced.

- In Vienna, biometrics can only be scheduled after arrival. Applicants submit a passport stamp or flight ticket to confirm their arrival date, and a negative COVID-19 test result. This causes delay in obtaining residence permits.
- Extension applications should still be submitted via email, if possible.
- Approved residence permits are being delivered via regular mail.
- Address registrations are to be completed via email.
- Most consular posts have reopened. Please check with your consular post before visiting.
 - The embassy in New Delhi currently only accepts residence permit applications.

Current Operational Status of Government and Immigration Authorities

- Initial and renewal Work Permit, Temporary Permit, Permanent Permit applications and other related documents are being processed. Applications can be filed at the State Migration Service (SMS) Section of Azerbaijan Service and Assessment Network (ASAN) centers by appointment, scheduled via the ASAN website, mobile app or call center.
- Suspension of visa applications through Azerbaijan Embassies or General Consulates until further notice.
- E-visas are available to individuals permitted to travel under pandemic-related entry restrictions (as listed below).
- Nationals of Bahrain, Israel, Qatar, Saudi Arabia and the United Arab Emirates can obtain visas-on arrival.
- Individuals entering government buildings and using related state services must have a COVID-19 passport (showing complete vaccination against COVID-19); a COVID certificate (confirming recovery and immunity) or a doctor's exemption certificate except for individuals under the age of 18.

• All foreign nationals (except diplomatic passport holders, those with work permits and temporary or permanent residence permits and their family members) must have vaccination or exemption documents. Other individuals are refused entry if they cannot present vaccination or exemption

- documentation.
- Closure of land borders, except for cargo transportation.
- Transit is not allowed through Azerbaijan.

Other Requirements

 As State Migration Service offices are not yet accepting or shipping original documents, application documents for initial and renewal Work Permit, Temporary Permit, Permanent Permit, residence registration and other related documents can be submitted directly to the State Migration Service Department at any ASAN center. Foreign nationals can also collect their Work Permits, Temporary Permits, and Permanent Permits from the State Migration Service Department at ASAN centers.

Concessions

- Foreign nationals unable to exit whose residence registration expired can apply for a 30-60-day extension of their legal stay. Details on payment for the extension application are available on the Migration Service website. Once payment is completed, such individuals can reside in Azerbaijan legally for an extended period. A decision on the extension application is available on the Migration Service website.
- According to an announcement from the State Migration Service, Residence Permits can be collected from the Migration Authority without the presence of a foreign national if there is a Power of Attorney issued in the name of the company representative and confirmation of the state duty payment.
- Temporary Residence Permit applications can be submitted to the Migration Authority while the Work Permit application is pending.

- Eligible foreign nationals can enter Bahrain through the visa-on-arrival and visa exemption programs. However, it is recommended that foreign nationals obtain a pre-arranged electronic visa (e-visa) prior to arrival in Bahrain.
- In-person visits to any of the Labor Market Regulatory Authority and Nationality, Passports and Residence Affairs authority branches are restricted to individuals above 18 who have completed their COVID-19 vaccination at least 14 days prior to their visit or those who have recovered from COVID-19.

- Flights from Azerbaijan, Ethiopia, Iraq, Lebanon and Syria are suspended until further notice. This does not apply to humanitarian, medevac and repatriation flights.

• Negative result issued by an accredited laboratory from a COVID-19 RT-PCR test taken within 72 hours prior to departure, or from a COVID-19 antigen test taken within 48 hours prior to arrival in Bolivia. This requirement is waived for children age five and under, and residents of certain border cities (who may be subject to other specific requirements), among others.

- Fully vaccinated travelers do not need a preentry COVID-19 test result to enter Brazil. They must show proof (digital or printed) that they have completed a full regimen of a COVID-19 vaccine at least 14 days prior to departure in order to board their flight.
- The pre-entry COVID-19 test requirement is also waived for individuals who had COVID-19 within 90 days prior to traveling to Brazil (counted from the first day of symptoms) and who do not show any COVID-19 symptoms. They must show:

 - A medical certificate in English, Portuguese or Spanish signed by a doctor indicating the individual is asymptomatic and able to travel. It must include the individual's intended travel date to Brazil.

- On a temporary basis, foreign workers already in Canada who have secured a new job offer or are changing roles can leverage an expedited process to obtain interim work authorization.

For applications submitted while the foreign national is abroad, the host company's legal representative must sign a sworn declaration or commitment letter before a notary public, committing to the submission of these documents within the established period.
- Permanent residents who were outside Panama between March 13, 2020, and June 30, 2021, will not have that period counted towards the maximum allowed legal limit for remaining outside Panama.

- The government temporarily suspended the requirement for international passengers to complete a TM6 immigration form to ease passenger congestion at international airports.

 - Absences up to 12 months the revised guidance has expanded the list of what constitutes an important reason and now includes (but is not limited to) applicants who were: ill with COVID-19; in quarantine according to local public health guidance; caring for a family member affected by COVID-19; prevented from returning earlier to the United Kingdom due to travel disruption caused by COVID-19; advised by their university that, due to COVID-19, their course was moved to remote learning and they were advised or allowed to return to their home country to study remotely; advised by their university or employer not to return to the UK, and to continue studying or working remotely from their home country; absent from the UK for another reason related to COVID-19 (for example, they left or remained outside the UK because there were fewer COVID-19 restrictions elsewhere, they preferred to work or run a business from home overseas, or they would have been unemployed in the UK and preferred to rely on support from family or friends overseas).
 - Absences for more than six months but up to 12 months individuals who intended to be
 absent from the UK for no more than six months will be permitted to have a single absence of
 up to 12 months, treated as being an important reason where they have not returned to the UK
 due to COVID-19. This will not break their continuity of residence.
 - Absences exceeding 12 months individuals who were already absent from the UK due to an important reason and were forced to exceed the 12-month maximum period of absence will be permitted (without breaking their continuity of residence) for as long as they are absent from the UK; Similarly, individuals who already had an absence of up to 12 months due to an important reason and need to rely upon a second period of absence of up to 12 months will be permitted, provided that one of those absences is because of COVID-19 (as described above). Note that while this absence will not break the person's continuity of residence, it will not be counted as residence in the UK for the purposes of qualifying for settled status. Also note that if they hold pre-settled status and this is due to expire before they can complete the continuous qualifying period of residence, they will be eligible to apply for a further grant of pre-settled status.
 - Documentary evidence applicants will be required to provide evidence of the length of and reason for any absence relating to COVID-19. The guidance also provides a list of suggested documentary evidence.

Employers and foreign nationals have 90 days to file a Form I-290B appeal or motion or Form N-336 hearing request to reopen a USCIS decision that was issued between November 1, 2021, and March 23, 2023 (inclusive). These accommodations do not affect the obligation to timely file applications for extensions of stay or employment authorization. For USCIS notices dated after March 23,

petitioners and applicants will no longer have an additional 60 days to respond and will instead be required to respond by the deadline specified in the USCIS notice. Petitioners and foreign nationals will also no longer have 90 days to file a Form I-290B appeal or motion or Form N-336 hearing request to reopen a USCIS decision that is issued after March 23. The deadline will revert to the standard timeline – 30 days in most cases.

 - The Immigration Department in Hanoi remains open. The Immigration Department continues to

- strictly review and scrutinize applications for the entry of foreign nationals. Therefore, delays in processing should be expected.
- Additional requirements/information are expected to be requested by the authorities without advance notice, which may cause more delays in processing.
- Ho Chi Minh City (HCMC)
 - The Labour Department in HCMC is open and continues to receive JPA applications, new work permit applications, as well as renewal applications for foreign nationals. Note that applications are initially submitted online for review and shortly after the hardcopy documents/application forms are sent to the Labour office for deliberation.
 - While new and renewal work permit applications are accepted, applicants must arrive in HCMC first before applications to the Labour office can be filed.
 - The Immigration Department in HCMC remains open. The Immigration Department continues to strictly review and scrutinize applications for the entry of foreign nationals. Therefore, delays in processing should be expected.
 - Additional requirements/information are expected to be requested by the authorities without advance notice, which may cause more delays in processing.

Definitions

Health assessments: Country governments are using terms such as "health checks" or "medical checks" or "health assessments" and similar inconsistently. For example, in saying that "a health check is conducted upon entry" - (1) in Country A this might mean that upon entry, travelers' vital statistics are checked generally, while (2) in Country B this might that the traveler is assessed specifically for COVID19-type symptoms. For the purposes of this document, we use the following definitions:

General health assessment: A generalized check of a traveler's medical state, which might include a temperature reading, a blood pressure reading, or other vital statistic checks.

COVID-19 assessment: A "general health assessment" that includes an additional specific screening to confirm the traveler does not present with COVID-19 symptoms. This may or may not include a COVID-19 test.

COVID-19 test: A polymerase chain reaction (PCR) diagnostic or other test specifically testing for a COVID-19 positive or negative result.

Quarantine: When comparing countries worldwide, we found that government authorities are using the term "quarantine" and related concepts inconsistently. For example, in saying that "entrants must be in quarantine for 14 days" - (1) in Country A this might mean that upon entry, travelers are placed on a government-organized bus and taken to a facility where they will be kept in isolation, while (2) in Country B this might that the traveler can drive their own car to their own residence and remain there in isolation, and meanwhile (3) authorities in Country 3 have yet to define quarantine officially and anecdotal reports of individual traveler experiences have been inconsistent. For the purposes of this document, we use the following definitions:

Enforced Quarantine: Official government guidance indicates there are penalties/fines associated with noncompliance with quarantine rules or requirements. These differ and can range from a fine to deportation, depending on the country. Note however, if a country's information in this document does not include the word "enforced," this does not mean the country will not impose sanctions on those who violate quarantine requirements.

Government facility: The quarantine will take place at a specific government designated location. Depending on the country, this might mean a hotel, or a hospital or other medical facility, or at a temporarily established quarantine location.

Home quarantine: The traveler must remain isolated in their own personal home or residence.

Monitored quarantine: There are government mechanisms through which officials will confirm an individual is properly isolating themselves. Methods may vary from requiring a traveler to call into a governmental phone-line each day to verbally confirm they have not been in contact with other people to having officials make periodic visits to a traveler's quarantine location to confirm they are there and isolated.

Residential quarantine: The traveler must remain isolated in a residential location, but not specifically the traveler's home. They might also be able to isolate at a friend or relative's home or other suitable residence. This is as opposed to a "Home quarantine," which must be undertaken at the traveler's personal residence specifically.

Self-isolation: Largely interchangeable with "quarantine." For the purposes of this document, we use "self-isolation" instead of "quarantine" if that is the word choice made in a jurisdiction's official announcements.
